#### 1. BACKGROUND

The Botswana Examinations Council is a semi-autonomous body created by the Botswana Examinations Council Act Cap 58:03 of 2019 Botswana Examinations Council is a Parastatal organization under the Ministry of Child Welfare and Basic Education. The mandate of BEC is to conduct school examinations and other examinations for the Ministry of Child Welfare and Basic Education, to award certificates in respect of the examinations it operates.

Such examinations are normally written around the country between the months of October and December annually.

## 4. SPECIFICATIONS

The facilities sought to be used as examination venues should meet the requirements or standards of examinations, and they should provide an environment in which the candidates feel comfortable. The following are required:

- Convenient and easily accessible by public transport,
- Adequate ventilation (e.g., large windows or airflow systems)
- Sufficient natural and/or artificial lighting
- Quiet environment, free from external disturbances
- The condition and status of the buildings are expected to be structurally habitable and fit for purposes.
- Lockable doors and secure access points.
- Safe and secure to use as an examination venue
- Adequate parking space for use by BEC personnel, examiners and the candidates.
- Adequate number of restrooms with running water for the number of candidates and officers housed
- Clean tap water for all the candidates and examiners
- Office space for invigilators.
- Access to electricity during examination hours
